#### INFORMATION PAPER

### Update from other Scientific Advisory Committees

#### Advisory Committee on Animal Feedingstuffs (ACAF)

ACAF is scheduled to meet on 17 February and items on the agenda include:

- **Refuse Derived Fuels** representatives from the Grain Feed Trade Association (GAFTA) and the Environment Agency, will seek the Committee's views on potential risks caused by refuse derived fuels;
- Update on the Review of the Report on On-farm Feeding Practices Tim Riley ACAF's sub group Deputy Chairman will present the final conclusions on the review of the Committee's report on On-farm Feeding Practices. The Committee will then be asked to adopt the final report document;
- British Society of Animal Science Accreditation Register Members will receive an update from the British Society of Animal Science on the work this organisation is carrying out on the Accreditation of Animal Scientists and Animal Technologists; many of whom carry out research, teach, and advise on the feeding of farm animals.; and
- Update on EU proposal on medicated feed a representative from the Veterinary Medicines Directorate will provide Members with information on European Commission proposals on revising the medicated feedingstuffs regulation.

#### **Future meetings**

Meetings of ACAF in 2016 are scheduled on:

- 17 June in Pilgrims House Aberdeen; and
- 27 October in Aviation House.

## Advisory Committee on Novel Foods and Processes (ACNFP)

The next meeting of the ACNFP is scheduled to be held on 3 February. The Agenda has not been finalised.

The ACNFP is holding an open meeting on 4 February. Presentations are planned to be given on

- the new Novel Food Regulations and
- Novel food applications what makes a good application.

This will be followed by smaller break out group discussions on

- Food and medicines continuum
- Alternative protein sources and
- Engineered nanotechnology with an emphasis on how they may contribute to a healthy diet

Recruitment of new members:

The ACNFP is recruiting 5 expert members:

- 2 experts in allergy 1 specialising in clinical allergy, and 1 in plant science,
- 1 expert in microbiology specialising in the gut,
- 1 expert in toxicology and
- 1 expert in molecular biology (GM).

Recruitment began during the week of 22 January and interviews are expected to be held in mid-March.

#### Committee on Toxicity (COT)

The COT will be meeting on 2 February and agenda items are as follows

- Potential future discussion items horizon scanning
- Review of risks arising from the infant diet and the development of atopic and autoimmune disease: Systematic review C Part II – Dietary Exposures during Pregnancy, Lactation and/or Infancy for Reducing Risk of Allergic or Autoimmune Outcomes: a systematic review and meta-analysis. (Reserved Business)
- Enquiring About Tolerance (EAT) Study- A randomized trial of the early introduction of allergenic foods in breastfed infants. (Reserved Business)
- Third draft statement on the role of hydrolysed cow's milk formulae in influencing the development of atopic outcomes and autoimmune disease. (Reserved Business)
- Review of potential risks from arsenic in the diet of infants aged 0 to 12 months and children aged 1 to 5 years
- First draft addendum to the 2013 COT statement on potential risks from aluminium in the infant diet.

## General Advisory Committee on Science (GACS)

GACS met on 1 October 2015.

This was the first meeting for Professor Alan Boobis as a GACS member. Professor Boobis attends the GACS meetings as Chair of the Committee on Toxicity of Chemical in Food, Consumer Products and the Environment.

Items discussed at the meeting included:

- the regular FSA Science Report to the Committee
- crosscutting issues in Science in the Scientific Advisory Committees (SACs), which included a presentation by the Chair of the Committee on Mutagenicity, Dr David Lovell, on the work of his committee
- an update on FSA Science, Evidence and Information (SEI) Strategy 2015-2020 and its Delivery Plan
- a presentation on the UK Agri-Tech Strategy Skills Analysis by Professor Robert Webb
- a presentation on the FSA work on Data Science by Robin Linacre and
- an update on the Review of the SACs by Susan Pryde
