12.4	E-coli Food Standards Agency requested to provide a briefing paper updating Members on implementation of the Task Force's recommendations.	This item is scheduled for the agenda for the December ACMSF meeting.
12.5	Study of external packaging of raw meat and offal from retail premises Secretariat requested to clarify with Health Protection Agency (HPA) why no mention was made of where packaging had been stored.	HPA commented that because the meat samples were taken from retail premises the information on the storage of packaging was not collected / known. However, it should be noted that the samples where the packaging was broken at the point of purchase had higher contamination levels. HPA also noted that there is a move away from cling film packaging and into heat sealed packaging which also results in less direct contact with the meat product.
