Update from other Scientific Advisory Committees

#### **Advisory Committee on Animal Feedingstuffs (ACAF)**

## ACAF 8 May 2013 meeting

- A Member of the Committee provided an account of discussions held by the Advisory Committee on Microbiological Safety of Food (ACMSF) at its meeting on 31 January 2013 on antimicrobial resistance. The Member, who had been coopted onto the ACMSF subgroup on this subject, asked the Committee for assistance in highlighting areas in relation to feed and antimicrobial resistance which could be raised at the ACMSF meeting.
- An official from the Food Standards Agency gave an update presentation on the implementation of the five work streams that have been developed following the outcome of the review of official feed controls which aims to deliver improvements to the current system. Members were encouraged that progress had been made to implement the work streams by April 2014. One of the work streams includes revision of the draft Code of Practice on Feed Law and Members agreed to provide the Secretariat with their comments on the proposed draft of the document. The Committee agreed that work to improve the delivery of official feed controls was an important area and therefore wished to receive regular updates on the work of the implementation team;
- The FSA Assessor asked the Committee to consider a paper that summarised its review of potential gaps in feed chain controls. Members agreed that the paper covered all of the Committee's views and findings and thanked the FSA assessor for its production. It was agreed that this topic will be periodically reviewed.
- A representative of the Pet Food Manufacturers Association and two industry representatives provided a presentation to ACAF Members on pet food issues including the re-authorisation of feed additives. The Committee sympathised with the issues raised and agreed to provide assistance where it can do so.

In June 2013 ACAF members provided comments on an ACNFP paper on effects of GM feed and non-GM feed in pig. The committee's comments were considered during the ACNFP's discussions at its meeting on 26 June 2013.

#### Date of future meetings

The next ACAF meeting is scheduled to take place in Aviation House on 9 October 2013. Provisional agenda items for this meeting include:

- iodine in animal feed Members to consider the animal feed implications of the dietary intake of iodine in humans;
- insects as a potential source of animal feed Members will receive a
  presentation from FERA officials on work being carried out to evaluate the
  potential for the generation of economically viable products from insects;
- consumer engagement Members will receive a presentation from ACAF Member Ann Davison on consumer related issues.;
- feed law enforcement review implementation programme Members will receive an update presentation from an Agency official on the Feed Law Enforcement Review Implementation Programme; and
- update on official controls 882/2004 Members will receive a presentation from a Food Standards Agency official on developments in relation to the Official Food and Feed Controls EC 884/2004.

As part of their review of the Agency's quantitative data needs the Committee recommended commissioning waves 3 to 5 of Food and You.

## 2. Domestic Kitchen practices:

This study explored kitchen practices in 20 case study households via a mixed method approach, including observation and depth interviewing. The study also included a small feasibility study to assess the possible application of activity recognition devices and how they may help in understanding kitchen practices.
